3. Is this Door to Door Moving?

Yes, this is Door to Door Moving. We provide a complimentary comprehensive survey which can either be Onsite or Virtual. Our quotation includes the provision of standard moving materials based on the type of move. Every confirmed move comes with a complimentary MOVEPREPTM service.

4. Do you provide other services such as handyman, piano moving, cleaning services?

We provide all ancillary services through 3rd party providers we have worked with. This enables us to focus on our core capabilities. By working with specific providers we can ensure that the customer is deriving the best value through competitive pricing, customer experience and innovative approaches.

5. What about the handling of speciality items like specific ART?

Yes, we are able to assist with the packing, handling and transportation of ART and many speciality items. Some of these we handle in-house with custom crating and special packing materials and for certain projects we might work with speciality handlers.

6. What types of international moving insurance will SIR provide?

ALL RISKS TRANSIT INSURANCE to cover any financial implications as a result of potential damage or loss.

"Sea-Marine All Risks" Insurance

This covers the consignment against partial/total damage or loss. This policy takes effect the moment the movers arrives at your premises to pack and it will remain in force until delivery at your next destination. Most policies covers Loss / Damage / Mould / Mildew, Electrical and Mechanical Derangement.



Mould, mildew, or fungi loss shall be covered as a direct result of fire, the direct ingress of water into transporting trailer or ocean container and inclement weather during container loading operations. Other causes of mould, mildew or fungi, including, but not limited to condensation, humidity, atmospheric conditions or changes in temperature are excluded from coverage.

A. Detailed/Itemized Inventory Valuation

You will need to provide the quantity, description & replacement value of each item or group of items. Storage Extension Cover is available should your goods require Storage for any length of time.

B. Lump Sum Insurance

If you elect not to complete the valued inventory list, you may opt for lump sum insurance. Each cubic meter (cbm) of goods is given a fixed value. There is no need to figure out the value of small or inexpensive items because each cubic meter is allocated the same value. The Lump sum insurance is a value per cubic meter (cbm).

7. What is SIR MOVEPREP™?

It is a pre-move planning session with the customer and the assigned Move Manager before a move starts and it is usually conducted over the phone or WhatsApp Video Call.

This session will address all the details involved in the complete move process, taking into consideration new updates and anything not addressed prior to the session. It may take the form of one or several sessions depending on the complexities of the move. It is complimentary and forms part of your Move Package. The outcome is for customers to feel better prepared prior to the arrival of the moving team.

8. What is MMB?

MMB stands for MOOVE MY BOX. Simply put, it is a Courier Service for anyone who needs to send I Box or more to just about anywhere. Unlike traditional courier companies, MMB goes one step further as we can offer partners and customers full packing and protection services.

9. Does SIR have any certification for Quality such as ISO?
